Each policy of insurance shall include the City of Cleveland as an additional insured and The City of Cleveland shall be listed as a certificate holder (The Department of Law may require greater coverage in each case to indemnify the City of Cleveland against any and all damages arising from the use of Class III, IV Laser.)
